## **ABOUT CNE**

The National Electoral Commission of Portugal was created in 1974, to regulate the election for the Constituent Assembly, the new Constitution was approved in 1976 and is still in force.

The Commission is the high body of electoral administration, it is independent and works before the Portuguese Parliament.

Throughout the last 49 years, CNE has regulated and monitored over 640 elections and 15 referenda.

CNE is now composed of 10 members, who are independent when exercising theirs functions and who cannot be removed from office.

The President is a judge from Supreme Court of Justice, to be appointed by Superior Council of Judges. The other members are citizens of renowned merit (nowadays 6), to be elected by the Parliament, in a single list, being each one proposed by a parliamentary group, and three experts, appointed one by each governmental departments with competencies for the areas of Internal Affairs, Foreign Affairs and Media. CNE can appoint delegates and usually there are CNE's delegates for the autonomous regions of Azores and Madeira.



This plural composition has brought an equilibrium to CNE, which is reflected by the fact that most decisions are adopted by consensus or unanimity.

The National Electoral Commission aims to promote the objective awareness of citizens regarding elections and referenda, to ensure the equality of treatment of all citizens in all operations of voter registration, as well as regarding elections and referenda, and to ensure equal opportunities of political action and campaign of all candidacies in a given election, as well as regarding those campaigning in referenda.

CNE is currently enhancing international cooperation with organizations such as A-WEB and the Network of Electoral Jurisdictional and Administration Bodies of the Portuguese-Speaking Countries Community (ROJAE-CPLP).

Matt is the Chief Executive of the International Centre for Parliamentary Studies. He has extensive experience of both the private sector and the workings of government. He is presently the Chairman of the International Centre for Electoral Psychology and has assisted numerous Heads of States and Heads of Governments in their endeavor to engage with the electorate and to sustain their democratic principles through the electoral process.

Cesar is a seasoned international electoral specialist with over 18 years of experience in electronic voting systems, biometric voter registration, and online voting. João Almeida Commissioner Portuguese National Election Commission

João graduated in Philosophy from the University of Coimbra. He has held various public positions for around 40 years and is now retired. For 20 years, the functions performed also involved electoral processes at both local and metropolitan level.

João was appointed member of the National Electoral Commission by the Portuguese Parliament in March 2003 and successively until the present legislature (2005, 2010, 2011, 2015, 2019 and 2022).

João is the former site's administrator and spokesperson, is now the Commission's elected secretary.



Joaquim Morgado Commissioner Portuguese National Election Commission

Joaquim serves as Deputy Secretary General of the Ministry of Internal Administration and heads the Portuguese Electoral Administration (AE/SGMAI), overseeing national voter registration and elections at various levels. In 2018, he spearheaded the Electronic Voting Pilot for the 2019 European Parliament election in Évora. Despite challenges posed by the COVID-19 pandemic, his team successfully managed multiple elections in recent years. Since 2022, Joaquim has been a member of the National Elections Commission.

With over two decades of experience, Joaquim has coordinated intricate projects in domains such as ICT, Security, and Cybersecurity for several governmental entities, including CEGER, PSP, CI-RNSI, UTIS, ITIJ, CNCS, and INEM.



Ingrid Bicu Expert in Gender Disinformation

Ingrid is a Research Associate at the University of Salamanca, who has had a progressive career of over 17 years in international affairs and in the electoral field. She consistently focuses on exploring opportunities and challenges stemming from rapid technological advancements through a human rights lens. Ingrid provides expert contributions to national and international organizations across areas including emerging digital challenges, artificial intelligence (AI), cybersecurity, strategic communication, open source and competitive intelligence.

A substantial portion of her current research centres on the impact of digital and Alenabled technologies on human rights and democracy. Ingrid places special emphasis on contexts marked by instability and conflict, with a particular concern for women and marginalized groups.



Wafula Chebukati Former Chairman at the Independent Electoral and Boundaries Commission (Kenya)

Wafula is the former Chairperson of the Independent Electoral and Boundaries Commission in Kenya and former President of the General Assembly of Association of African Election Authorities. During his tenure, he displayed exceptional leadership by overseeing comprehensive electoral reforms and fostering an environment of cooperation and trust among various stakeholders due to his unwavering commitment to transparency and accountability. His tenure emphasized the vital role of integrity in the democratic process.

He is an Advocate of the High Court of Kenya with 37 years post-qualification experience and a trained legislative drafter and policy formulator. He holds a Bachelor of Laws and a Master of Business Administration degree.



Greg Essensa Chief Electoral Officer Elections Ontario

Greg was appointed Ontario's Chief Electoral Officer with the unanimous consent of the Legislature in June 2008. He is the seventh person to hold the position. Greg has over 35 years of municipal, provincial and international election experience. Over the years, he took on positions of increasing scope and responsibility and prior to his appointment he served as the Director of Elections and Registry Services for the City of Toronto.

As a dedicated election official, governments of all levels, associations and not-for-profit organizations have sought his election administration expertise. He has advised on municipal elections in British Columbia, Alberta, Quebec and New Brunswick and primary elections in Illinois, North Carolina, Ohio and Texas. Born and raised in Toronto, Mr. Essensa studied economics at McGill University.



Alberto Guevara Former Director of the Electoral Tribunal of the Federal Judiciary (Mexico)

Alberto is a political scientist, with Master's degrees in Public Policy and Public Administration, and a PhD in Law. He served at International IDEA as member of the Secretariat of the Global Commission on Elections, Democracy and Security, where he worked with former Heads of State and former UN-Secretary General Kofi Annan, to put together recommendations to strengthen the integrity of democracy.

In Mexico, he worked as political communications advisor for the Specialized Prosecutor for Electoral Crimes in the aftermath of the 2006 elections. Later, Alberto was appointed General Director of International Relations at the Federal Electoral Tribunal, where he organized and participated in more than thirty observation missions in Europe, Asia, Latin America and the Caribbean. He currently advises public and private sector organizations on institutional relations, streamlined processes, and strategic communications.



Dr. Madhukar Gupta State Election Commissioner, Election Commission of Rajasthan, India

Madhukar is a Mason Fellow from Harvard University and has gained a global perspective with international expertise in areas like Public Administration, Public Policy Making, Environment, Disaster Management, and Health.

Gupta's contributions have been recognized on international platforms such as the United Nations Development Programme (UNDP). His role has taken him to locations like Hawaii ,George Washington University and several renowned Universities highlighting his global influence. He has engaged with prestigious international institutions, including the World Bank, UNDP, and the University of Maryland, sharing his insights on critical subjects. His expertise and contributions have transcended borders, making him a notable international figure.



Thomas Hicks Commissioner U.S. Election Assistance Commission

Thomas was confirmed by unanimous consent of the United States Senate on December 16, 2014 to serve on the U.S. Election Assistance Commission (EAC). Prior to his appointment with the EAC, he served on the U.S. House of Representatives Committee on House Administration from 2003 to 2014. Mr. Hicks recently completed the Election Center and Auburn University's Certified Elections/Registration Administrator (CERA) program. He received his J.D. from the Catholic University of America, Columbus School of Law and his B.A. in Government from Clark University (Worcester, MA).



Toby James Director Electoral Integrity Project

Toby is Professor of Politics and Public Policy at the University of East Anglia. He is currently Co-Director of the Electoral Integrity Project, an independent academic research project based at UEA and the Royal Military College of Canada/Queens University. The project produces innovative and policy-relevant research to improve elections worldwide. The flagship publication is the annual Global Electoral Integrity Report.

Toby's research focuses on the electoral integrity and democracy, the policy process and political leadership. Toby has written commissioned policy reports for national and international organisations, and collaborated with organisations such as International IDEA, IFES, the Carter Center, Westminster Foundation for Democray and the UK Foreign Office.



Giorgi Kalandarishvili Chairperson Central Election Commission of Georgia

Giorgi is the Chairperson of the CEC of Georgia since 2021. He graduated with honours in Information Technologies and holds an MA in Law with distinction. Since 2008, he has obtained various managerial and decision-making positions at the CEC. Under his leadership, several noteworthy initiatives were progressed within the CEC: an international standard ISO 9001:2015 was introduced, Administration successfully underwent two international annual control audits, showcasing and maintaining high standards of EAs; the Chairperson's proactive initiative led to the effective inception and development of strategies for combatting disinformation; the successful conduct of pilot electronic elections and the full-scale implementation of electoral system modernization through the electronification is a path firmly rooted under the leadership of Mr. Kalanadarishvili.



Anna Nyqvist Chief Executive Swedish Electoral Authority

Anna is Director of the Swedish Election Authority (SEA), the principal body for managing and evaluating Sweden's general elections at the national level. Responding to growing challenges in election administration globally, Nyqvist has been instrumental in advancing electoral best practices, with a strong focus on securing the integrity of the electoral process and enhancing voter outreach. Her tenure at the SEA has been marked by fostering strategic partnerships and fostering a culture of information sharing across Sweden's electoral infrastructure.

Formerly the Executive Office Director of The Swedish Customs, Nyqvist brings over two decades of experience within the government sector, contributing her expertise to numerous councils and boards across Sweden. Her academic pursuits are rooted in Political Science and Economics, providing a solid foundation for her contributions to public service.



Judge Patricia Lorenzo Paniagua Junta Central Electoral (JCE) of the Dominican Republic

Patricia serves on the Board of the Junta Central Electoral (JCE) in the Dominican Republic and leads both the Technology and the Equality and Inclusion Policies Commissions. She is also part of the Association of Electoral Magistrates of the Americas (AMEA).

Driven by a commitment to challenge systemic biases against women and marginalized groups, Patricia actively champions women's political engagement and combats political violence through numerous conferences. As a key member of the JCE's Plenary Board, she is dedicated to fostering a social and democratic state governed by law in the Dominican Republic, prioritizing the political participation of women as a cornerstone of her mandate.





Denis Kačan Product Lead Neurotechnology

Denis possesses extensive experience in the biometrics and identity management industries. At Neurotechnology he is responsible for biometric solutions development and overseeing their successful implementation in national scale projects.
